#### 1. Introductions

- a. MSHSAA's Toni Hill who replaces Davine as Executive Director who will oversee Spirit.
- b. New Executive board members
  - i. Stephanie Simon, new vice president
  - ii. Brittani McCellan-East regional rep
  - iii. Zoe McCarthy-Academic All State
- 2. Constitution and Articles of Incorporation
  - a. Verified name and address changes
  - b. Review of roles and responsibilities
    - i. Restate Bylaws was updated in 2014 and voted on by membership.
    - ii. No constitution, only the updated restated by-laws due to what is required when we incorporated in 2014. Policies and Procedures also predate 2014 and are not valid.
  - c. Issues and concerns
    - i. When charter members started, each school had one coach. Now, some schools get have more coaches and more votes.
    - ii. One school, one vote. Board members get a vote, but retired coaches and businesses would not.
    - iii. Proposal for new language: In matters of elections and bylaw amendments, voting rights are extended to head coaches and executive board members only. One school, one vote.
    - iv. Sidenote: Ballots will specify if the election is for head coaches only or for all membership.
    - v. Karen Bahr motioned to vote on the amendment, Stephanie seconded. Motion passed.
    - vi. New concern: review and update Policies and Procedures, determine if it is needed.
    - vii. Nikki proposes new language for Qualifications: A member running for president should be a member of the MDTA executive board for two consecutive years prior to the election. Karen Asbell seconds. Motion passed.
    - viii. Goal is to find more members at large across the state, particularly from the southwest region. Julia at Smithville could potentially be in charge of social media
    - ix. Nikki will create a member feedback and concerns to be mailed out prior to each meeting.

- b. At state team and solo competition, would you be in favor of breaking scoring ties?
